Περιγραφή μαθήματος

Στόχος του μαθήματος είναι να εξετάσει το ρόλο της ΕΕ στο διεθνές σύστημα, το πρότυπο των εξωτερικών σχέσεων της Ευρωπαϊκής Ένωσης ιδιαίτερα με τους σημαντικότερους γειτονικούς της χώρους -Βαλκάνια, Τουρκία, Μεσογειακές χώρες, καθώς και τη διαδικασία της διεύρυνσης της ΕΕ, τις συνέπειες και προοτικές της. Θα αναλυθούν επίσης οι σχέσεις της Ένωσης με τη Ρωσία, τις ΗΠΑ, αναπτυσσόμενες χώρες, η θέση της στους παγκόσμιους οικονομικούς θεσμούς (GATT, ΠΟΕ, κ.λπ.) και η κοινή ξωτερική πολιτική και η πολιτική άμυνας της ΕΕ (ΚΕΠΠΑ/ΚΠΑΑ), ιδιαίτερα στο πλαίσιο της Συνθήκης της Λισσαβώνας. Τέλος θα αναλυθεί ο ρόλος της Ελλάδας στη διαμόρφωση των εξωτερικών σχέσεων της ΕΕ.
